PART 1 – JOB DESCRIPTION

1. JOB OVERVIEW

To manage the implementation of Tearfund's contractual obligations of its OFDA funded Emergency WASH and Food Security project in Eastern DRC, through providing strategic leadership, support, monitoring, and coordinating the implementation and reporting from Tearfund's operational team in the DRC. The post holder will also provide support and advice to ensure that the sub-awardee effectively implements and reports on their activities.

Overall oversight of budget of up to \$3.5 million

2. POSITION IN ORGANISATION

The post-holder is responsible to the Programme Manager (DRC).

The post holder will:

- Provide leadership and strategic direction of a multi-province emergency WASH and Food Security programme, to ensure delivery of results
- Together with and as delegated by the Programme Manager, represent Tearfund in meetings with OFDA.
- Work closely with Tearfund staff in DRC. Particularly the provincial Area Managers, WASH Advisor, WASH Managers, Finance Manager, MEAL staff and Grants & Information Officers.
- Closely liaise with the USAID donor lead and Programme Funding Manager at UK level.
- Work closely with the sub-awardee focal point to ensure activities are tracked and compliance is adhered to.
- Have delegated responsibility to represent Tearfund in networks with Government Departments in the focus provinces on matters relating to the project.
- Ensure Tearfund's representation and active participation in WASH and Food Security clusters at provincial level.
- Advise senior leadership on programmatic and contractual issues

3. ORGANIZATIONAL REQUIREMENTS

- The post-holder will, at all times, carry out their responsibilities with the utmost respect for the protection of children and vulnerable adults in accordance with Tearfund's Safeguarding Policy.
- The post-holder will be expected to behave in accordance with Tearfund's 'Code of Conduct' as referred to in the Personal Conduct Policy.

4. PARTICIPATION IN THE SPIRITUAL LIFE OF TEARFUND

- Join corporate weekly Staff Prayers, to hear of Tearfund's work and to spend time in prayer and worship together

5. KEY RESPONSIBILITIES

4.1. PROJECT COORDINATION

- Facilitate regular meetings between field-based operational staff and Programme Manager to ensure project activities are on track and to share learning to increase overall improvement of project implementation and organisational learning
- Ensure regular coordination meetings with the sub-awardee to ensure project activities are on track and to share learning to increase overall improvement of project implementation and organisational learning
- Ensure implementation plans include appropriate strategies to increase the quality and sustainability of WASH and Food Security service delivery
- In collaboration with the Programme Manager, Area Managers and technical advisers, revise implementation plans to address potential challenges/issues. Act as focal point and ensure effective dissemination of key messages and information to DRC programme staff.
- Responsible for maintaining in-country filing and version control of key documents in relation to this contract.

4.2. PROJECT MONITORING, EVALUATION, ACCOUNTABILITY AND LEARNING

- Undertake regular participatory monitoring and verification visits to ensure adequate progress against action plans, outputs and ensuring that quality elements are signed off. Provide advice on any corrective action necessary.
- Design and implement systems, based on other WASH and Food Security programmes in the DRC, to monitor and track progress towards the indicators
- In consultation with the finance manager, monitor the overall project budget spend, to ensure programme is being delivered in line with the contract price/budget, compile and review monthly budget-v-actual financial reports.

4.3. PROJECT REPORTING

- Coordinate with the Grants and Information Officers and consolidate the monthly and quarterly reports both from Tearfund and from the sub-awardee, and submit these on time and at the required quality to Tearfund's Programme Manager and Tearfund's Programme Funding Manager and USAID donor lead in UK.

4.4. PROJECT DONOR COMPLIANCE

- Design and implement systems to ensure donor compliance. Provide training and awareness for Tearfund and sub-awardee staff on OFDA contract conditions and ensure system design and implementation of such conditions and compliance.
- Work with the finance and logistics staff to ensure monthly review of financial and procurement compliance to contract conditions.

4.5. EXTERNAL REPRESENTATION

- Maintain constructive relationships with key stakeholders and represent Tearfund at different cluster and NGO coordination meetings in country.
- Establish and maintain constructive working relations with other NGOs, UN agencies, Government departments in focus provinces.
